

- 4) GRACE PERIOD: GRACE PERIOD OF MAXIMUM 2 DAYS SHALL BE PROVIDED ON MONTHLY BILLING. NO GRACE PERIOD ON WEEKLY BILLING
- 5) BILLING CYCLE: BILLING CYCLE WILL BE MONTHLY BASIS I.E. IF A CONSIGNMENT IS RECEIVED ON 07.09.2021 ONE MONTH WILL BE OVER ON 06.09.2021 AND GRACE PERIOD WILL BE TILL 08.09.2021. THE WEEK WILL BE TILL 13.09.2021 WITH NO GRACE PERIOD
- 6) MATERIAL RECEIPT: MATERIAL RECEIPT WILL BE ISSUED TO THE PARTY'S REPRESENTATIVE, IF NOT AVAILABLE THEN TO PARTY'S TRUCK DRIVER CARRYING THAT CARGO ALONGWITH THE SIGNATURE OF PARTY'S REPRESENTATIVE / TRUCK DRIVER ON THE MATERIAL RECEIPT ISSUED BY FHFL.
- 7) THE CONSIGNMENT OF THE PARTY SHOULD CARRY A CHALLAN OF CARGO ALONGWITH NAME OF THE FIRM, LOTWISE DETAILS ETC.
- 8) THE RATES FOR THE CARGO RECEIVED FOR TRANSIT PURPOSE ONLY I.E. RECEIVED AND DESPATCHED WITHOUT STORAGE, HALF OF THE WEEKLY RATES WILL BE CHARGED. HANDLING CHARGES WILL BE AS PER THE HANDLING TARIFF

- 10) PER PALLET PER MONTH RATE OF RS.1,000/- EXCLUDING GST, IF ANY WILL BE CHARGED FOR THE PRODUCTS LIKE FRUIT SYRUP ETC.
