1. **Name of post** : Chief Operating Officer (COO)- 01 (One) Post

2. **Pay-scale** : ₹ 43,200-66,000 (IDA)

(For deputation, officers should be working in CDA grade of ₹ 15,600-39,100 (GP ₹ 7600/-) or above or IDA scale of ₹ 36,600-3%-62,000 or above or its equivalent in Govt./quasi-government organization).

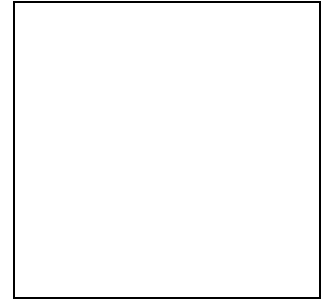
