A. Name of post: Sr. Supervisor Consultant (Marketing) Number of posts : 02 (Two) Nos.

i) Job Description:

The candidates selected as Sr. Supervisor Consultant (Marketing) will be responsible to increase the direct sale of FHEL apples outside Delhi in the areas like Hyderabad, Ahmedabad, Bhuvneshwar, Kolkata, Chennai, Siliguri, Gauhati, etc.

ii) Job Specification:

(a) Ed. Qualification: Graduation (full time degree), however, preference will be given to candidates possessing Post-Graduation degree in Marketing.

(b) Experience: One year experience in marketing of fruit & vegetables, preferably apples, kinnows & oranges. **Proof of experience must clearly indicate the total year(s) of experience in marketing of fruit & vegetables, designation held, salary drawn, etc.**

(c) Age: Not more than 45 years of age (as on last date of receipt of applications).

B. General conditions:

1. The candidates selected for the above positions will be paid a lump sum consultancy fee ranging between ₹25,000 - 30,000/- per month. The consultancy fee will depend upon qualification, experience, etc. of the candidate and will be subject to deduction of taxes as per applicable income tax rules.
2. The candidate selected as Sr. Supervisor Consultant (Marketing) will be engaged initially for a period of one year which is extendable for further period at the sole discretion of management subject to physical fitness and satisfactory performance of the candidate.
